- A. Discussion and possible action to approve the checks issued listing and monthly financial report for the period ending February 28, 2021.
- B. Discussion and possible action to adopt Resolution 2021 – 05, which authorizes the Board Chair and Clerk to execute an Intergovernmental Agreement with Pima County Wireless Integrated Network for radio support and maintenance.

The PCWIN radio maintenance is provided by PCWIN and Pima County Wireless Services. The current IGA with Pima County is expiring and a new IGA is required.

- C. Discussion and possible action to authorize the Fire Chief to execute a Software, hardware and support services Agreement with CentralSquare Technologies, LLC for a Computer Aided Dispatch system.

Following termination of the process with AT&T/Rapid Deploy, District staff re-evaluated a CAD program available with our current vendor, CentralSquare. Based on that review and the information provided by other users, staff has recommended switching to the CentralSquare Pro Suite CAD.

The discussion could include topics such as all revenues and expenses, tax rate implications, operating costs, capital costs, personnel costs and future impacts of the District's assessed values on programs and staffing.
